NOTE:

1. In the case of all courses, where there is joint paper setting system amount payable For setting the question paper and evaluation of answer books shall be divided equally bet been The paper setters/examiners.
2. Self stamped envelope shall be sent to the paper setter and an Amount of Rs..15/- only shall be Paid as contingency charges. For theory examination an Amount of Rs.. 25/- and Rs..60/-- for local And outside examiners will be paid respectively as contingent charges..

In case any examiner/ Sub-Examiner spends more than the amount Admissible as above he/she may claim reimbursement on submission of actual receipts. In case Claim is made up to fired charges bill need not to be sent . No contingency will be paid if the Answer Books/Question papers are dispatched and collected by the office. Contingency will be Paid if the examiner submits the answer-books in the office personally.

3. The staff member. who are entitled to avail vacation/ holidays/Sundays will be paid remuneration at double the rates. For performing examinations duties during vacations/ holidays/Sundays-
4. A' person committing upto s mistakes pep 100 copies shall be penalized @ Rs.. 10/- per mistake. In case a person commits more than S mistakes per 100 copies he shall also be liable for for disqualification from work.

6. The rates of remuneration for B.. Arch. (Theory & Pract.) as well as portfolio examinations The rates of Punjab University be followed because of the reason that the course of B. Arch. does not exist in any other University in the stats.

7. So far as the revision of rates of Practical examinations are concurred for the present status quo be maintained and in the meantime rates from other Universities be arranged/ obtained.
8. In case of any other course not covered above or which may be introduced by the University , The Vice-Chancellor will be competent to approve the rates of remuneration etc.. by clubbing The same with the equivalent existing course.
9. In respect of the Computerized Results. The scrutiny be stopped as internal check wherever Required is to be exercised by the concerned official only..
